SUMMER HOUSING APPLICATION/CONTRACT Application deadline: Friday, April 29, 2011

By submitting a summer housing application/contract, I hereby agree to the following terms:

- I understand a **priority summer housing deadline of Friday, April 1, 2011** has been established for:
 - 1) students enrolled in summer courses,
 - 2) students participating in summer research, an internship or practicum related to their academic major (must be endorsed by a faculty member of the academic department of the student's major), and
 - 3) students participating in a faculty/staff endorsed college-sponsored activity (must be endorsed by the faculty/staff member responsible for the college-sponsored activity).
- I agree to pay the following applicable summer housing fee and understand the appropriate charge will be added to my student account:
 - o \$200/month or \$50/week – Double occupancy (with roommate)
 - o \$300/month or \$75/week – Single occupancy (without roommate)
 - o No charge - Seniors (90 or more cumulative credit hours by Aug. 1 and confirmed by the Office of Student Affairs) residing on campus for the summer and following fall and spring semesters
- I understand that the aforementioned fee does not include a meal (board) plan.
- I agree to abide by all campus and residence life policies and procedures as outlined in the *William Jewell College Student Handbook and Survival Guide*.
- I understand advanced authorization by the Office of Student Affairs is required to move in/vacate my summer room on a different date/time from the established openings and closings. Failure to do so will result in my student account assessed the improper check-in/out fee.
- I understand summer housing placement is the sole discretion of the Office of Student Affairs and placements are made on a first-come, first-serve basis.
- I understand that single occupancy rooms will be authorized on a first-come, first-serve basis, space providing.
- I understand that this application/contract is only binding upon approval by the designated administrator with the Office of Student Affairs. Applicants will be contacted by the Office of Student Affairs to confirm summer housing.
